## NZPAC Service – Schedule rectification for voyages 0503/0504/0505

Dear Valued Customer,

Please be advised that that due to berth congestion in the Islands, the PFL Matai 013S has been delayed by approx. a week against her proforma schedule. To rectify the schedule and bring her back on window:

- PFL Matai 0503 will perform a truncated voyage of Tauranga Auckland Suva Lautoka Tauranga and will only load exports to Fiji (and Fiji Transhipments). All exports for Apia and Nuku'alofa will be rolled to the Capitaine Tupaia 0504. She will resume her normal NZPAC rotation on voyage 0506
- Capitaine Tupaia 0504 will call Apia and Nuku'alofa
- Capitaine Tasman 0505 will call Apia and Pago Pago
