Simplification of Local Charges for Australia, New Zealand, and Fiji

Imports and Exports Effective 1 October 2026

Dear Valued Customer,

We are pleased to advise that, **effective 1 October 2026**, we will be simplifying how local charges are categorised and presented on invoices for Australia, New Zealand and Fiji imports and exports. This change reflects our ongoing commitment to reducing complexity and streamlining invoices for our customers.

To achieve this, some existing charge code lines will be consolidated into new subtotals on each invoice. **This change only affects how charges are described and grouped on invoices. The total dollar amount charged will remain unchanged.**

The tables below show the new consolidated charge structure alongside the current charge structure for each market and equipment type, plus the aggregate charge values:
